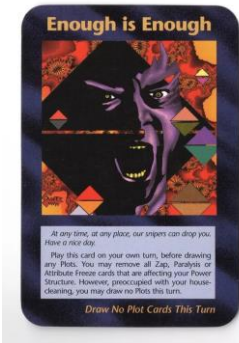

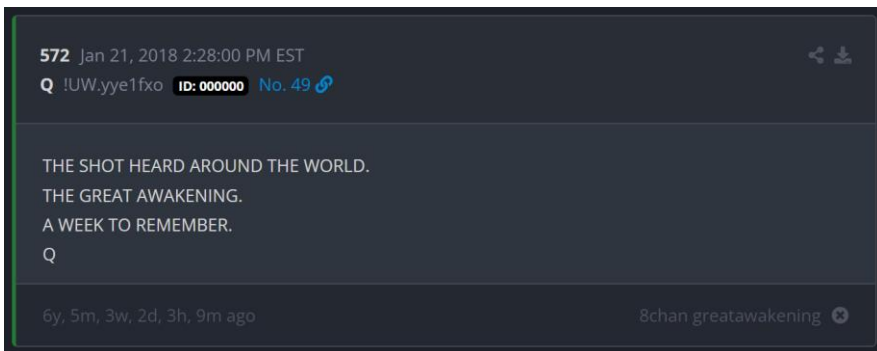

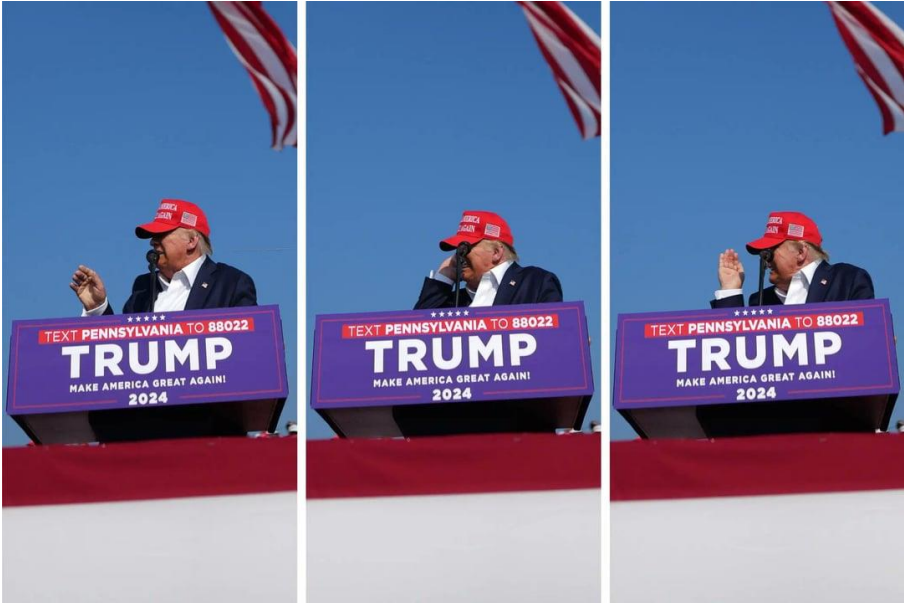

### The Bullet, the Blood, and the Ear

SEVERAL shots rang out at precisely **6:11 p.m.**, as many as six to eight rounds, but before they did, Trump spoke the following words.

“If you wanna really see something that’s sad, take a look at what happened.....” [bang... bang... bang...]

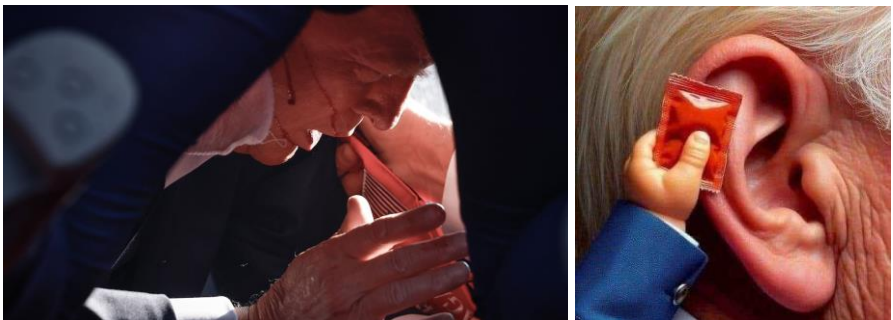
Like you, I have replayed the footage repeatedly. I have even reviewed it at quarter speed, and here is what I see happening. At the last possible millisecond, Trump turns his head towards stage left, presumably to read from a chart. Immediately after the first pop, Trump’s right shoulder flinches. He pauses, and I will remind you, the footage has been dramatically slowed down. He then moves his right hand towards his ear, as if agitated. Before contact is made with his ear a second pop rings out. The sound of yet another pop, potentially the third of several, accompanies Trump as he looks at his open-faced hand, checking for



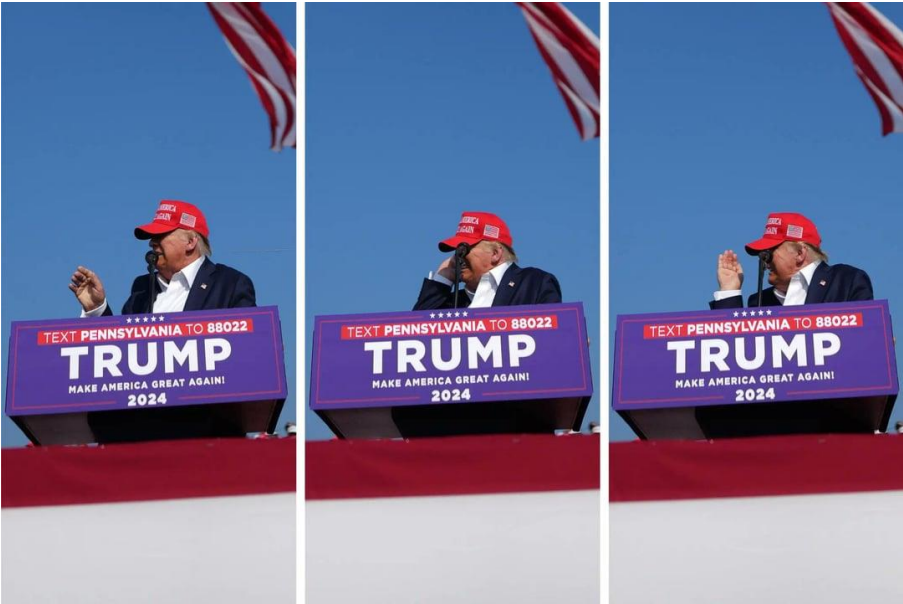
blood. Somebody yells: “Get down!” in which several Secret Service agents form a human pyramid on top of him.



We do not see Trump again on camera for an entire minute, though I counted **59 seconds** in total. In that span of time, we can hear the Secret Service barking commands, waiting on clearance. “When you’re ready,” “Move,” “Up,” “Move,” “Go,” they can be heard saying, in which Trump emerges a disheveled man, bloodied, concerned about not leaving his shoes behind. It takes another several seconds for Trump to collect himself, but when he does, a sudden rush of adrenaline must have set in, because he tells his detail to “Wait” before turning to the crowd, pumping his fist in the air, and pronouncing “Fight” three times.



As I was saying, Trump emerges with a bloodied ear, two distinct crimson trails streaking towards his mouth. The hoaxers are going to say he faked that. They are going to recall his days in the **WWE**, in which pain was a performance and played a part in the pleasure, *noted*. It is not surprising to find a meme passed my way within hours of the event in which a packet of blood was applied to an uninjured ear for dramatic effect. To be honest, it was my first thought as well. In the entire minute that the Secret Service doggy-piled on top of him, any one of them could have easily cracked open a packet. They didn’t. I will explain why that is in a moment.



My initial question was the **bullet**. How do we know there were actual bullets sprayed into the crowd and not blanks? One person was reportedly killed, and two others were injured. Sure, we've seen these staged hoaxes elsewhere and are familiar with the crisis actor simulation. What are the chances that the actual bullet which grazed Trump's ear would be captured by the very photographer who documented the blood on his hands. That's a one in a million shot, like the actual bullet. Won't somebody hand that man a Pulitzer prize? They faked it via composite imaging is what some of you are thinking. The bullet is magic, the blood is artificial, and the photo is a composite. *Oh fine*. Let's keep snooping around, then.



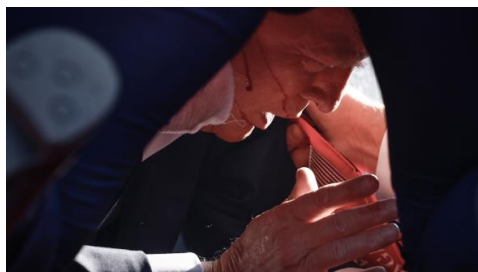
Regarding the question of his ear. Assuming a bullet made contact, you would expect an entry and exit wound. An **AR-15** rifle was used, no? Some

are saying his ear should have been blown clean off. In the very least, shouldn't he be missing a slice of the pie? On close inspection, a section of his ear is unaccounted for. And I know what the hoaxers are already thinking, seeing as how I think that way myself. That long drawn-out dog pile was the perfect opportunity to snip a little chunk off the ear, courtesy of Trump's WWE buddies. Well, as I am about to show, even I disprove myself sometimes. The blood packet and ear-piercing theory are about to be thrown out the window.



For the longest time I could not detect blood on his fingertips, which had my suspicion. If his ear had already begun to bleed, then there should have been residue on the fingertips. Especially since blood can be found in digital pictures, a discrepancy for sure. Are we staring at a post edit? No, look again. The video footage is low-def, for sure. Quarter speed is still too fast of a playback. It's why I'm offering you a still frame of the precise micro-second when the photo was simultaneously taken. On closer inspection, his fingers are red. And so, at what point did he or anybody else open up the blood packet? They didn't. Even supposing he was hiding a blood packet in his sleeve, like a magician with a bird, then who the hell ripped it open, certainly not Trump, and where did he hide it afterwards?

Actor or no actor, there is no room for error. Bang... bang... bang... The order of events sequentially line up, and in nanosecond time, which is quicker than Olympic time and lightyears beyond microwave time. Trump's reaction time is immediate and consistent with the pain reaction one would expect of the nerve stimulus, and the secret service reaction time appears within protocol, though they have problems which will also be examined.



Among the many claims coming my way, there is not enough blood, and should be more. Noted, that may be. The ear has a rich blood supply. Blood can be seen collected on a handkerchief of some sort if that helps. Perhaps still not enough. Others insist the two streaks of blood ricocheting across his cheek were planted to look like a bullet grazed him, which would be amateurish if true. In fact, you can see the forming of those two streaks when his security detail is piled on top of him. Yet another claim has the blood vanishing from his hand when he rises from the podium. Why are they saying that, because he formed a fist? Come on, can we please try a little harder when proving our hoaxes? If this is a hoax, and it may be, then why would they clean the blood from his hand in the minute interval between his falling and rising? He would need all the blood that he could get. Clearly, the blood is still accounted for when he opens the palm of his hand.

Was the ear snipped or not? Did the blood appear before he fell or after he rose back above the podium? The blood did appear on his hand before he dropped, and we're talking within a nano-second of time. Pop, his shoulder flinched. Pop, his hand was on his ear. Pop, blood was on his hand, and he dropped. The ear was shown to be clipped when he rose back up. Ears are **90% cartilage**. The upper outer crest is the least vascular part of the ear. A nicked ear is surely possible. We can throw around opinions about how much blood there should or shouldn't be,

and that aspect should be evaluated, but based upon the other suggestion, that his security detail cut his ear for the hoax, then there still would have been blood, whether lots or little. You can't have it both ways. And as I've shown, the blood can be seen before he dropped.

Why then was there no blood on his shirt? That's another question, and a good one. I don't know. If a blood packet was used, as is the suggestion, then fact of the matter is, real blood or fake blood, his shirt was pressed and clean. I'm thinking it was because the blood dripped towards his mouth rather than his collar when he was down for the count. Speaking of which, why stop at one blood packet? There was an entire security team piled on top of Trump. This happened in Western Pennsylvania of all places. Ample opportunity to crack open another couple of packets, maybe even bring out the old HEINZ bottle of Tomato Ketchup while they're at it, but no.



[UPDATE 7/18/24: The photographer's name was **Doug Mills**, a veteran photojournalist of the NY Times. I'm referring to the iconic photo of the bullet which can be seen whizzing past Donald Trump's head. It has already been listed as a one in a million shot, no pun intended, and has likewise become quite the point of contention within hoax circles, as I thought it might. If there were no bullets fired then how could one be captured on film, you see what I mean? **Michael Harrigan** has stated that, though it is extremely unlikely Mills was capable of capturing such a photo, it is possible. Harrigan is a Retired **FBI Special Agent**, by the way. That will not sit well with most of you, nor the fact that Mills worked for

the **NY Times**. Plant your red flags for all I care. I carry my own. You should be happy to know that millions of angry liberals are doing forensic work on this very photo, as we speak, all trying to figure out why the bullet missed, and they will soon determine whether this one, like thousands of **NASA** images, was a composite image or not. Until proven otherwise, I think it is genuine.



I thought it might be a good idea to familiarize ourselves with the iconic work of Doug Mills. It's not every day you catch a bullet, but this wasn't exactly a one off for him, either. The dude is good, adapting his aperture and shutter speed for every occasion.



[UPDATE 7/25/24: So, it's like this. I perform various image searches using exploratory key words, and how is it that Google never once offers Doug Mill's most famous photo of all? Yup, Doug Mills was hired to photograph **George W. Bush** reading **'The Pet Goat'** to a class of 2<sup>nd</sup> graders on the morning **of 9/11**, which changes everything. Good old Google, giving me the runaround. To help set this in context, Doug Mills was hanging around in the **Reagan**'s living room, catching the tube. He was there for **George H.W. Bush** exchanging spit with **Gorbachev**, **Bill Clinton**'s photo-op with Israeli Prime Minister **Yitzhak Rabin** and Palestinian leader **Yasser Arafat**. He was even jumping out of bushes like a punk in order to capture Clinton ditching his detail for a Big Mac. The Reagan hangout was clearly staged. Come to think of it, they all were. And so, I will ask you again, what is a person with Mills pedigree and panache doing in a 2<sup>nd</sup> grade classroom?]

Regarding the bullet in Butler shot, the criticism has much to do with Mills using a camera that can take images at up to **30 frames per second**. The photo was captured with a shutter speed of **1/8,000 of a second**, which is incredibly fast. We're talking **combat** speed fast. Here is what former FBI Agent Harrigan told the Times.

“Most cameras used to capture images of bullets in flight are using extremely high-speed specialty cameras not normally utilized for regular photography, so catching a bullet on a side trajectory as seen in that photo would be a **one-in-a-million** shot and nearly impossible to catch **even if one knew the bullet was coming**.”

Harrigan ended his quote by insinuating that a photographer might already know the bullet was coming, *wait*, what? Interesting phrasing. Whether that is an admission or not, the hoaxers are saying Mills already knew what was coming, which is why he was shooting at 1/8,000. That may be so, I couldn't say either way. And in fact, I am leaning towards the opinion that the Media expected a very different outcome if you know what I mean. Just try not to confuse Harrigan's message. Even if the photographer knew what was coming and had his finger poised on the shutter-release button, it was still a one-in-a-million shot. Accept it.



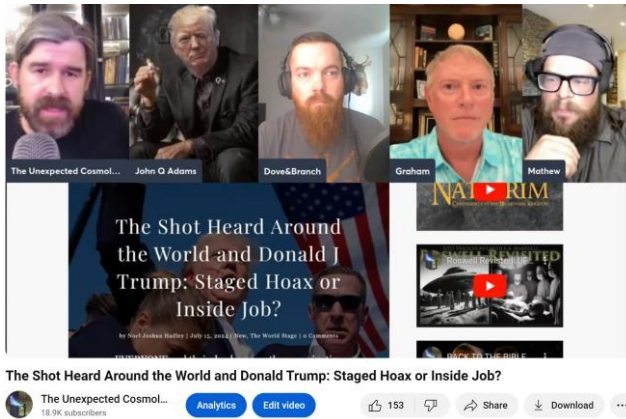

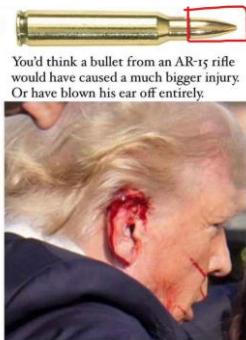

I happen to like it that way. **Graham** is a noted presence at TUC. **JohnQAdams** has published a book with us, [Q and the Millennial Kingdom](#). He's a **Marine** veteran with two tours of Iraq, whereas Dove&Branch, though we call him **Chuck**, is an 8-year Army veteran with a combat tour in Iraq and another tour in Kuwait. Plenty of ballistics experience among the both of them, which is important, since their immediate response upon watching the assassination attempt footage was that **.223** or **.556** rounds were being fired. Prior to the shooting Mark Violets uploaded a video on YouTube claiming "justice is coming".



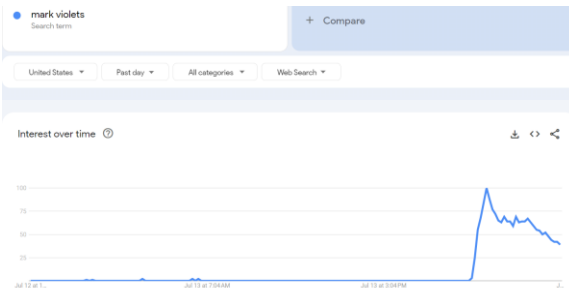

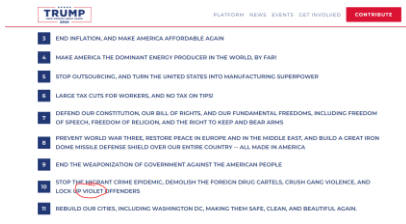
## Mark Violets

[**UPDATE** 7/16/24: Within hours of the shooting, perhaps even minutes, disinformation agents were already out and about on social media saying the shooter was somebody named **Mark Violets**, and that the Butler Police Department had arrested him. Apparently, he was an **Antifa** member who had earlier been claiming via YouTube video that “justice was coming.” It wasn’t him. I’m still not convinced it was Thomas Matthew Crooks either, but we’ll get there. The person pictured is **Italian sportswriter** and video blogger **Marco Violi**. He posts about the Italian soccer team AS Roma rather than Antifa. Also, he was in Rome during the shooting, not Pennsylvania. You have to wonder if Marco Violi did something where Intel made a public spectacle of him.



There does appear to be a Mark Violets character online though he may be a fictional character whom Intel had intended to use for the PSYOP. Why they ditched him for Crooks is anybody’s guess. It is certainly interesting that no searches for Violets occurred at any time in his past. But then, beginning at **5 a.m.** on the morning of the shooting, Mark Violets became a curiosity piece. His name produced several searches before the operation went LIVE. Afterwards, a name search skyrocketed only to begin tapering off. I will ask, how did people know to search his

name before it even happened, and most importantly, only upon the day when it would happen?



The very mysterious and non-existent Mark Violets becomes even more of a curiosity piece when we look at **Number 10** on Trump's website, which is gleaned from his official website.

**10 STOP THE MIGRANT CRIME EPIDEMIC, DEMOLISH THE FOREIGN DRUG CARTELS, CRUSH GANG VIOLENCE, AND LOCK UP VIOLET DEFENDERS.**

Why the typo? Surely, somebody from his staff would have corrected the error by now. And then check out **Snoop Dogg's** music video, '**Lavender**'. It features the assassination of Orange Man and can be tossed into the predictive programming pile, for sure. Lavender is a **pale violet**. One might argue that the name of the music video made no sense at the time. Though I do recall the assassination of Orange Man, he released it in **2017**, I can honestly claim that I've never listened to a single Snoop Dogg song from beginning to end, thank YAH, and therefore cannot back the claim regarding its sensibility. 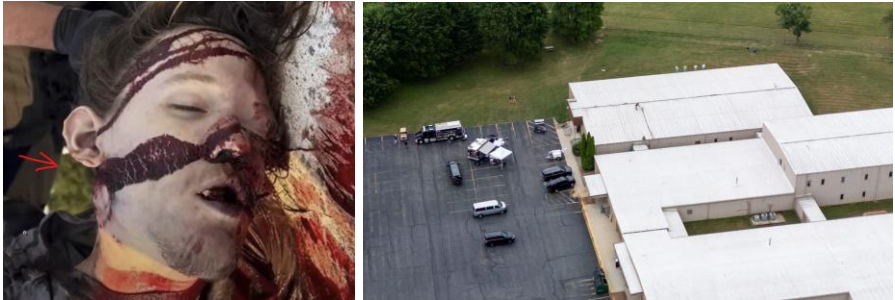


### Thomas Matthew Crooks

Obviously, Marco Violi is not a match, and Mark Violets didn't do it. The dead guy on the roof has been identified for us as **20-year-old Thomas Matthew Crooks**, and just look at his corpse, why don't you? Do a search on trauma victims and tell me how many of them die with their eyes closed. This isn't my first rodeo. When a person dies, his muscles tend to relax. The jaw usually falls slack with the mouth agape, as we see with Crooks. But then, quite unlike Crooks, the eyelids will also open, eyes rolled back. Closing one's eyes may be a Hollywood tactic but incredibly difficult to do in reality. There is a reason as to why corpses receive the coin treatment. When compared with the blood on the sloped rooftop, the blood on his face hasn't aged too well. The timing of the two seem out of sync. The blood on the roof has a

**Frazzledrip** signature to it as well, taking us back to the days of **Anthony Weiner**'s laptop and **Pizzagate**. Potential signature aside, video footage has emerged which clearly shows Crooks crawling along the rooftop, and in real time. guns, Fillpot responded: “Long guns.” You do not get inside a Secret Service perimeter with firepower like that.

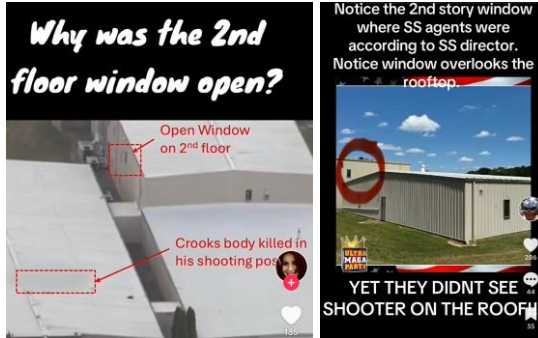

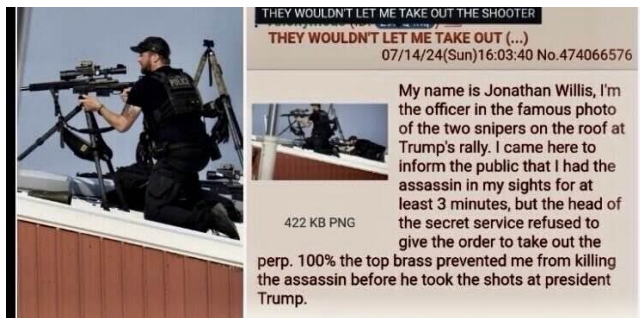

## Maxwell Yearick

**Atlanta, GA (Voting Rights Demonstration):** Maxwell Yearick participated in a protest emphasizing voting rights and access to democratic processes.

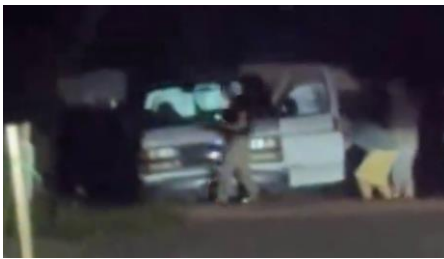
**Boston, MA (Anti-White Supremacy Rally):** Yearick attended a rally denouncing white supremacy, amidst clashes leading to property damage and arrests.

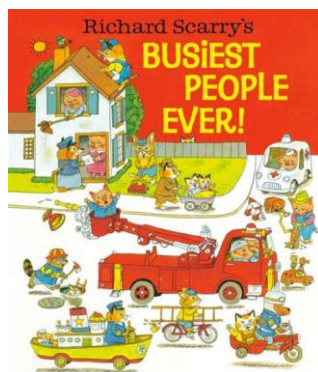
FYI, Maxwell Yearick's **social media accounts** were scrubbed from the internet shortly after **July 13**. Nothing to see there, I'm sure.

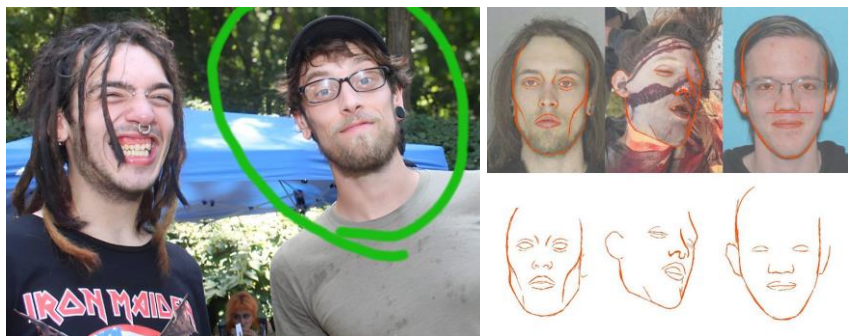

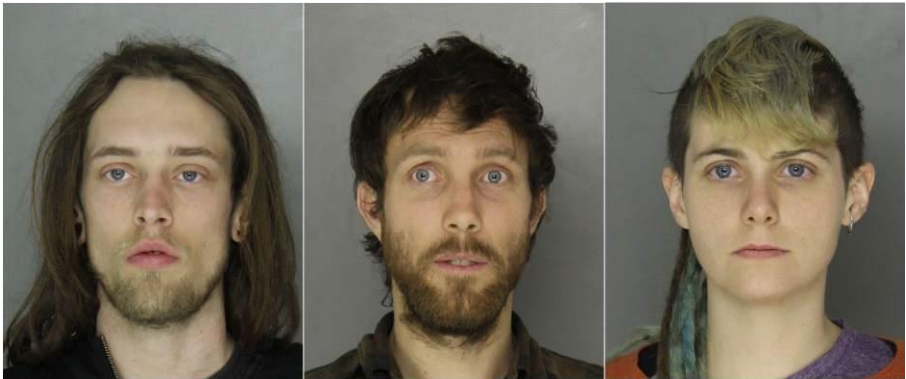

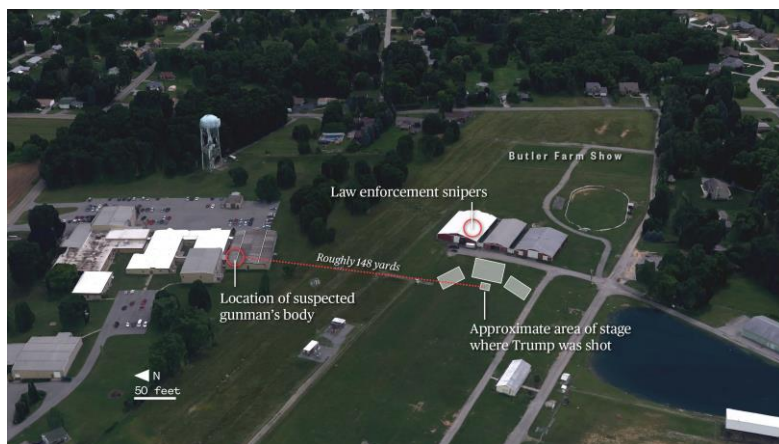

## Second Shooter, Second Sniper, Lines of Fire

[**UPDATE** 7/17/24: Apparently, a bullet smashed into a line on one of the cranes, causing an uptick of steam or smoke or what have you from the broken hydraulics. You will notice a great number of participants standing up, staring off to their right. We have been told the projector has their attention rather than the shot President but let's not even go there. It's as ridiculous a notion as they come seeing as how these are seasoned conspiracy theorists, well versed in the Kennedy Assassination of 63, and know what to look for whenever a **patsy** and a **second shooter** should arise to the occasion. In this instance, there may have even been a **third shooter**, according to some witnesses [**EDIT** 7/23/24: Make that a **fourth shooter**]. They very likely may have been looking to Thomas Matthew Crooks position on the slopping roof, an obvious eyesore and intended distraction, but then there was another vantage point from the same direction—the **water tower**.

From Crook's position to the stage is something like **148 yards**, which is precisely the distance to either rooftop surrounding the lake. Other witnesses distinctly heard shots coming from that direction. Why isn't eyewitness testimony being considered then? The only conclusion the Media wants you to come to is one which involves a pimply-faced kid, registered to the GOP, who nabbed his daddy's rifle and staked his position from the unguarded rooftop. All other testimonies are being repressed and pushed down the search results by Internet bots.

As I've already shown, the police and the Secret Service were made aware of Thomas Matthew Crooks long before several rounds were popped off. And then there is [this](#) latest report, which has Thomas Matthew Crooks' **parents calling police and telling them that their son was missing earlier that morning**. So dumb. Some of you will squint your eyes at the video and say it's inconclusive, and that all we're looking at is an early evening shadow. The dark spot not only moves, it's darker than every other evening shadow on the water tower, but whatever.



I dare you to give this [second video](#) a glance. If the link doesn't work, then I've supplied you with two separate screenshots. Oh, someone was there, alright. It's unmistakable this time around. A man clothed in black tactical gear can be seen crouching on top of the water tower, right knee up, left knee down, and he's holding a rifle, though the official narrative insists that no one was there.

The law enforcement sniper (unclear if USSS) in newsreels was clearly overwhelmed as his face came off his rifle instead of doing his job to kill the shooter. Clearly they were watching the shooter but apparently have a no "first shot" policy. The only positive action was an apparent 488yd shot by one USSS sniper which despatched the assassin but after the assassin launched at least 5 rounds, wounding DJT and killing and severely others in the crowd.



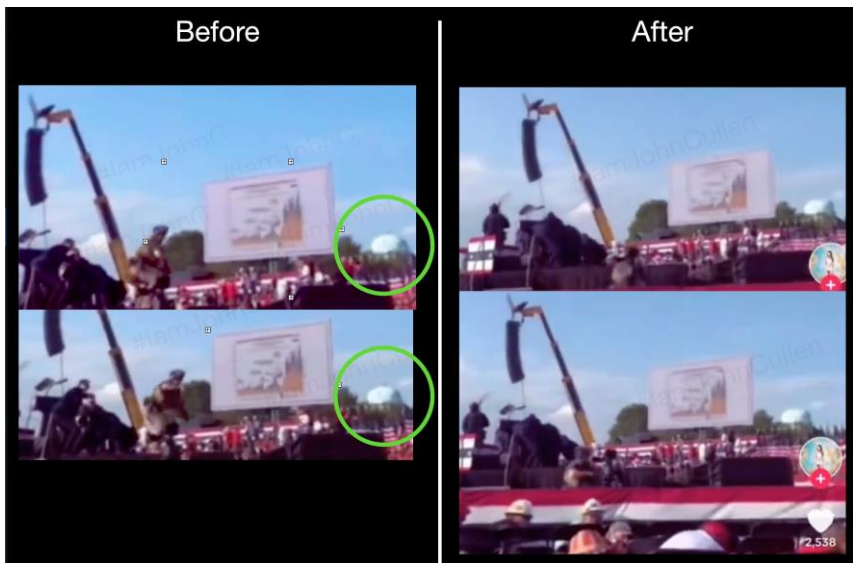
Worth noting is a statement made by former US **Navy SEAL officer** and **Blackwater** founder **Erik Prince**. He said in a [statement](#) that the sniper took out the shooter with a **488-yard** shot. 488-yards just so happens to be the precise relationship between the water tower and the counter sniper position. The provided photo was taken by a **Secret Service Counter Sniper Team** (CST) member who was

positioned there. That is his weapon. Not sure why they would take this photo nor why they would put it out publicly, but they did. What I'm uncertain of at the moment is if the red box was part of the original release or if others put the red box in there to help analyze the situation. Look closely anyhow. The red box is where Crooks was positioned. The base of the water tower can be seen just above the tree line. The counter sniper's weapon isn't pointing towards the red box. Difficult to tell from this angle, but the gun may not be pointing towards the red box at all. It very well may be aimed towards the water tower.



[**UPDATE** 7/23/24: Noting the possibility, no, the likelihood that the counter snipers sniped the water tower shooter, and that his return trip to the earth was more of a fast and sudden pancake impact rather than safe landing through the chute as planned, take a closer look at the dark spot on the cork, Many are claiming that be nothing more than a shadow. 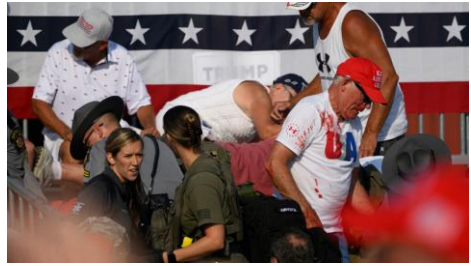

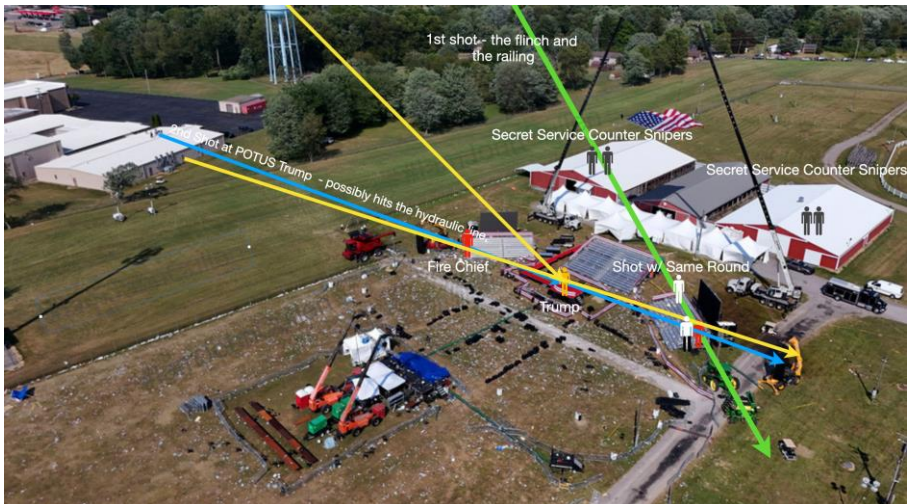


Complications arise when comparative [video footage](#) shows the precise moment of the first shot, though the camera is directed at the stands to the stage right of Trump rather than the stands behind him. If you have already lost your bearing, then look to the red barn with the sloped roof directly behind the jumbotron. It is a match with the arial photo. Two men are simultaneously shot, but is it the same bullet? They are penciled in the red circle for you. The first is wearing a white shirt and can be seen falling over. The second stands along the railing and is wearing a red hat. But how can that possibly be the first round's trajectory if Trump's ear was also cut into? It cannot. I asked the very question. There has to be another solution.





The only confirmed kill shot happened upon **Corey Comperatore**, the Fire Chief. He was seated in the opposite bleachers, stage left of Trump. The man in the white UA shirt, soaked in sweat and blood is **Jim Sweetland**, a former ER Doctor from Angels Camp, California, a town I happen to be fond of. He performed CPR on Comperatore for two entire minutes until a state trooper tapped him out, though Sweetland assumed him to be dead immediately on impact, seeing as he could see the bore hole into the right side of his head, immediately above the ear. In one [interview](#), Sweetland said he could see his brain matter splattered across the bleachers and mixed in with the blood. What shot took out who and when, and from where did they derive?



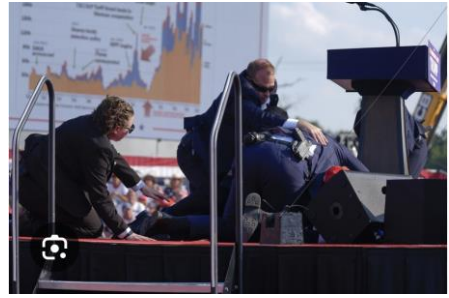
A fuller picture seems to have emerged within this diagram. It appears as though two rounds were simultaneously fired from two different respective positions. The bullet which grazed Trump's ears was timed with another. The shooters were synchronized. The two wounded men, as represented by the **Green Line**, stage right, can only be explained by a shooter far off in the tree line. The thought is that he was aiming at the

USSS Counter Snipers and missed. Why would they want to go after the rooftop Snipers? To give their boy on the sloped roof a fighting chance. The shooter from the sloped roof is represented by the **Blue Line**. His potentially hit the hydraulic line. Yet another shooter fired from an open window in the building below him, representing the **Yellow Line**. I'm guessing his took out Comperatore, though who really knows? There is another **Yellow Line** in this diagram stemming from the water tower, though I'm wondering if he ever took a shot to begin with.

Whatever happened to go down at Butler, Pennsylvania can only be explained by a volley of multiple shooters in league with each other, communicating: "Three, two, one, pumpkin practice." The kid on the sloped roof was let in by those who had set up shop in the building, the arrest was faked, and they probably even handed him his AR-15, and everybody was eager to claim the winning kill shot. The patsy's caterpillar crawl all boils down to the confidence he had in the conspirators who had hired him.



I was under the impression that sloped rooftops were far too dangerous for the dot-Gov crowd, particularly in Butler, but it sure does look like 'slippery when wet' isn't being taken into consideration, seeing as how they're whipping out the old fire hose. 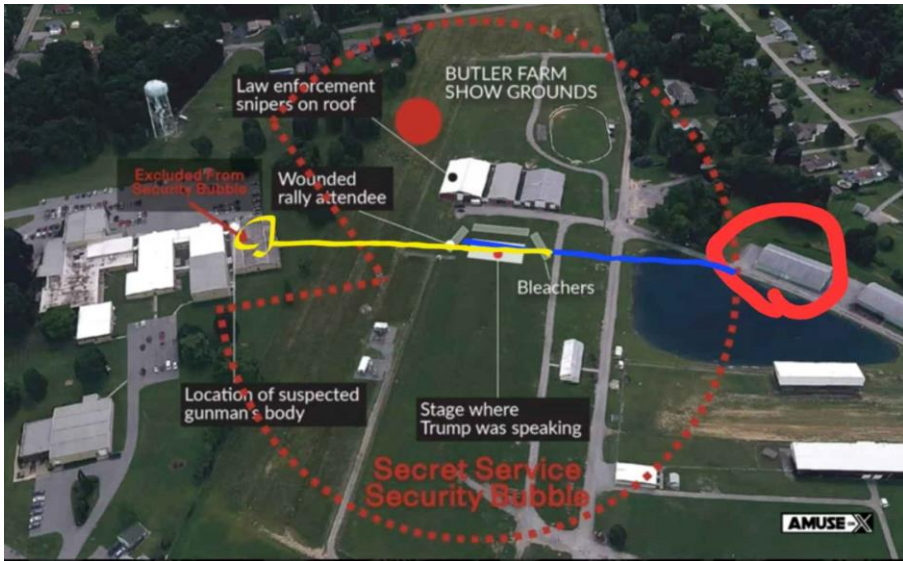
unfamiliar with standard protocols typically used at these types of events, according to the allegations.”

The first picture of Crooks was taken by law enforcement by **5:14pm** and he was shot at **6:11pm**. ## The Crowd Reaction

[**UPDATE** 7/23/24: Opinions have varied wildly between those who claim the crowd's response is subpar, indicative of crisis actors, to those who say the human reaction aspect is well within range of what one might expect during a live shooting. The truer answer very likely may be both. I would expect there to be a mix of real people as well as members of the Intel community present and accounted for, Deep State not excluded, and in some cases, crisis actors. That's just the way with it in any given PSYOP. We are confronted with the good, the bad, and the ugly. Though in this instance, I am under the impression that the assassin's bullet was expected to succeed, and that some crisis actors were standing by. Trump's own description of the crowd's reaction was given a few days later at the [RNC](#), adding further insight into the discussion.

The most incredible aspect of what took place on that terrible evening in the fading sun was actually seen later in almost all cases as you probably know, and **when even a single bullet is fired, just a single bullet, and we had many bullets that were being fired, crowd run for the exits, or stampede, but not in this case. It's very unusual. This massive crowd of tens of thousands of people stood by and didn't move an inch.** In fact, many of them bravely but automatically stood up looking for where the sniper would be. They knew immediately it was a sniper, and then began pointing at him. You can see that if you look at the group behind me. That was just a small group

compared to what was in front. **Nobody ran** and by not stampeding, many lives were saved. **But that isn't the reason that they didn't move, the reason is that they knew I was in very serious trouble**, they saw it, they saw me go down, they saw the blood, and **thought, actually, most did, that I was dead**. Even Trump admits that the crowd's response is not a usual one. Most will run for the nearest exit when just a single bullet is fired, he claims, stampeding others in the escape. If anything, most critics, be they liberals or those from the hoax crowd, seem to totally misrepresent who Anon's and all-around Trump supporters are and what they are capable of, being a peaceable people. At the same RNC event, **Tucker Carlson** gave further insight to the crowd's reaction during his 'Weekend at Bernie Biden' [speech](#). There were genuine screams alright. Those in attendance were rightfully afraid. I had even stated this some pages back, the fact that a great number of participants stand up, staring off to their right. He too sinks down a few seconds after, but never once do we see the blonde woman reaching out to grab and pull him down, nor does she cover his body, as a mother instinctually would. Kamala: I love you, Joe,

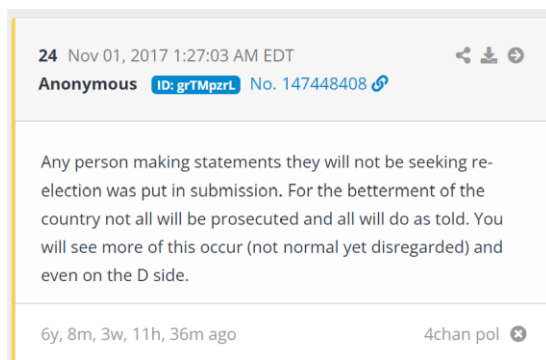
